2. Name/position should be **TYPEWRITTEN**. (Use only the AIRB Clearance Form). And
3. Attached one (1) copy of 2x2 ID picture with nameplate. Please paste the picture/s in a separate bond paper. Return the accomplished AIRB Clearance Form and other requirements at the Anti-illegal Recruitment Branch (AIRB)
4. Attached photocopy of NBI and MC (for married women only) and photocopy passport for foreigner. Submit the accomplished AIRB Clearance Form and other requirements at the Anti-Illegal Recruitment Branch (AIRB)

The AIRB Clearance is use as basis for the issuance of new license, renewal of license, accreditation of new officers/employees and upgrading of licenses.
